Public Hearing on Local Law # 1 Of 2018 Meeting Minutes

March 21, 2018

I. Call to order

Supervisor Bishop called to order the Public Hearing for Local Law # 1 of 2018 at 7:00pm on March 21, 2018 at The Town Board Room. The Pledge was recited.

II. Roll call

III. The Public Hearing for Local Law # 1 of 2018 was opened Supervisor Bishop went over the Local Law to the board:

LOCAL LAW NUMBER 01 of 2018
TOWN OF HINSDALE

Pursuant to Section 4S8-b of the Real Property Tax Law.

A LOCAL LAW NUMBER 01-2018 GRANTING A PARTIAL EXEMPTION FROM TOWN AND COUNTY REAL PROPERTY TAXES FOR COLD WAR VETERANS

BE IT ENACTED by the Town Board of the Town of Hinsdale as follows:

SECTION 1: Legislative Intent. It is the intent of this legislation to enact Local Law 01-2018 which grants an exemption of fifteen percent (15) of the assessed value of qualified residential property, as defined in Real Property Tax Law Section 4S8-b(2)(a)(i) to Cold War Veterans, as defined in Real Property Tax law Section 4S8-b(1)(a).

SECTION 2: Severability. If any provision of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, then such adjudication, shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the particular provision directly involved in the controversy in which judgment shall have been rendered.

SECTION 3: Effective Date. This Local Law shall take effect immediately upon its filing with the Secretary of State and shall be applicable to all assessment rolls prepared pursuant to the first faxable status date occurring on or after the effective date of this Local Law.

VII. Motion to Vote on Local Law # 1 of 2018 made by Councilman Wilson. Seconded By Councilman Noll.

Local Law #1 of 2018 passed.

VIII. Open Issues:

- a) Bids were received for the 25 X 25 ft. Building to store tools and equipment in until a new Town Barn can be built. Bids were received from:

Andy Michaels-\$8,675.00

Canal St. Contracting- \$8375.00

Lonnie Miller- \$9,600.00

- b) Councilman Brown addressed a concern that the Ins. Company may not pay for the whole building as the stated they would give us the price of renting 2 storage pods for 12 months towards the cost. He will call the insurance company to clarify what they will pay for the buildings cost.
- c) Motion to accept the bid from Canal St. Contracting for the building, contingent that the majority of the funds would be covered by the ins. company. Made by Councilman Brown. Seconded by Councilman Noll. Ayes all Motion passed.
- d) Supervisor Bishop reported that due to NYS Civil Service Law Section 75. Cynthia Nupp will have to be reinstated as Bailiff. Also we would have to give her any back pay that was due. **Motion** to have Supervisor Bishop write a letter to her reinstating her job made by Councilman Brown. Seconded by Councilwoman Powley. Ayes all.
- e) Supervisor Bishop will call an engineer to start getting quotes for our new building. He was asked to get a quote for the building that the Insurance Company will replace and one for a larger building that the Town would like to build.
