I. Call to order

III. Approval of minutes from last meeting

Clerk Carr presented the minutes from the last meeting. The minutes were approved as presented by a **motion** from Councilman Maerten. Seconded by Councilman Brown. Ayes All.

IV. Supervisor's Report: Received July 2020.

- a) Supervisor VanDeCar asked Hwy Supt. Mascho if the Highway Dept. could mow between Flanigan and Virginia St. as it is hard to see turning out of there.
- b) Supervisor VanDeCar reviewed the Financial report for July 2020.

V. Highway Supt. Report:

- a) The new chipper has been ordered and should be received the last week of Sept.
- b) The sinkhole on Morgan Hollow has been fixed and the culvert on Yardman Rd. is scheduled to be worked in 8/12 and finished the last week of the August.
- c) The battery disconnect switches have not yet been installed on the vehicles that need them.
- VI. Town Clerk's Report: Received July 2020.
- VII. **Justice Report**: Received July report and May revenue.
- **VIII. Dog Control Report:** None received.

- **IX.** Code Enforcement Report: Received June 2020. CEO Putt has sent out violation letters.
- **X.** Water Dept. Report: Received June 2020. 15 Delinquent letters were mailed.

XI. Open issues

- a) Perry Lovell has run the lines to Hwy Supt. Mascho's office. Spectrum still hasn't changed the Phone # on the lines.
- b) New Building: The generator has been rewired with a larger breaker. The emergency lights have been fixed
- c) C&L Enterprises (Perry Lovell) has prepared two proposals for upgrading the Towns phone system. **Motion** to accept proposal A for \$4,150.96.00 made by Councilman Brown . Seconded by Councilman Wilson. Councilman Noll-Absent.

XII. New business

- a) A resident complained about chickens running at large on Gile Hollow.
- b) The Town received bids from MacNeal Replacement windows for replacing the windows on the food Pantry. Proposal 1-to replace 13 windows: \$7,900.00. Proposal 2 -To reside the building: \$6,200.00. Also a proposal from Gutter Systems to put new gutters up for \$1,625.00.
 Motion to accept the 3 proposals for the Food Pantry Building by Councilman Wilson. Seconded by Councilman Brown. Councilman Noll- Absent
- c) The Town has received a donation from the Genevieve Russell estate for \$10,000. Towards building a new Dog Kennel. Currently we have \$16,475.00 in that account.
- d) The Town received a proposal for a generator for the well house from Ellman Electric for \$25,000. The board discussed the issue and agreed to table the proposal until net month and look at more options.
