- **V. Highway Supt. Report:** a) New Grader may be delayed 6 to 8 weeks due to electronics part shortage. b) Scrap metal is sorted still have to hall to scrapyard. c) Discussed the 2021 road projects with the Board. d) June 30 will be Carl Deibler's last day.

  - **X. Water Dept. Report:** Received April 2021. The well pump testing has completed 5 of 6 tests. Reports will be sent shortly. The second organic and inorganic testing is completed and everything was good

## XI. Open issues

a) Supervisor VanDeCar reported that the 2021/22 Chips -\$162,030 (+29%). EWR- \$36,570.70 (+54%) and PAV-NY - \$42,959.48(+50%) funding. Total 2021/22 = \$241.560.18. The State also reallocated 15% of the 20% of 2020

- funds withheld for a total of \$26,662.32. Approx. Total HWY Aid = \$268.222.50
- b) The new LED streetlights installation have begun on Main St., Flannigan Hill, and Gile Hollow.
- c) Ellman Electric is not interested in completing the well house project. The Town will need new electrician proposals.
- d) The board decided to replace certain sections of sidewalk this year on Main St. totaling about 252 feet.
- e) The Solar Law draft is being reviewed by Cattaraugus County Planner, Marie Meyers.
- f) Motion to approve hiring Andy Michaels to grind the tree stump in the Main St. Park for a cost of \$600. as long as he has proper insurance and calls Dig Safe made by Councilman Brown. Seconded By Councilman Noll. Ayes All Councilman Wilson- Absent.

### **XII.** New Business

- a) Residents Kristen and Kyle Keenan have requested that the Town abandon South Depot St. in order to stop people from dumping garbage, brush and trespassing on their land as the road dead ends on their property and they are the only residence on the road. Tabled until the June meeting.
- b) Motion to adopt MOU with Teamsters to allow the Hwy Employees donation of sick time made by Councilman Maerten, Seconded by Councilman Brown. Ayes all Councilman Wilson- Absent.
- c) Motion to allow the Town to enter into a contract with FSC Systems to provide Fire alarm inspection and repairs made by Councilman Brown. Seconded By Councilman MAerten. Ayes all. Councilman Wilson- Absent.
- d) FCS Systems will be providing the Town with a quote to replace our absolute fire monitoring system in the office building.
- e) The 2020 Annual report for the Water has been received and will distributed to water users. All testing levels were very good.
